As per the permission accorded by the Government of India Ministry of Health & Family Welfare, New Delhi vide Lr.No. U-120/2/589/2015-ME-I, Dt. 08.06.2016 and as per the orders of the Vice-Chancellor, KNRUHS, Warangal vide 6th cited and as per the Statues on affiliation of Medical Colleges of Kaloji Narayana Rao University of Health Sciences, Warangal it is hereby certified that the application of **Government Medical College, Mahabubnagar** has been registered with KNRUHS, Warangal and continuation of provisional affiliation is granted to run 4th year /Part-II MBBS Course for the existing batch and to make admissions with an intake of 150 (One hundred and fifty only) seats at **Government Medical College, Mahabubnagar** for the academic year 2019-20.

The Institution / College is fully responsible to fulfill the norms and to maintain the same which includes infrastructure both physical and human resource, teaching faculty and clinical material, etc., throughout the academic year, as stipulated in regulations of Medical Council of India.

The number of students admitted shall not exceed the number of students permitted for annual admissions both under University and Management Quota as specified by the Medical Council of India / KNRUHS.

The Fee collected by whatsoever name called either for University quota seats or for management quota seats should not exceed the limits specified by the State Government/Kaloji Narayana Rao University of Health Sciences, Warangal from time to time.

The Principal of the College shall follow the regulations made by the University/State Government and also the Graduate Medical Education Regulations 1997 of the Medical Council of India in making admissions, in conducting examinations and in respect of all other related matters from time to time. Any deviation, in this regard may lead to disaffiliation of the college without any notice. This order is valid for a period of one year.
